HOSPEEM Study Visit to Ireland in April 2014

On 17 April 2014, HOSPEEM visited its Irish member, the Irish Health Service - HSE. At the Irish Department of Health, the ongoing reform of the Irish health system was discussed. At the HSE Corporate Employee Relations Services (CERS), representatives of HSE CERS discussed with HOSPEEM their respective priorities. The focus was put in particular on the areas of common interest in the industrial relations and occupational health and safety fields where HSE CERS and HOSPEEM are closely working together and will further strengthen their cooperation. The day was concluded by a visit to one of the largest hospitals in Ireland, the Beaumont Hospital, and a meeting with its managing board. Read more.

NEWS FROM MEMBERS

Member's profile: Latvian Hospital Association

The Latvian Hospital Association (Latvijas Slimnīcu biedrība) is the Latvian member of HOSPEEM. It was created in 1997 and operates in the health care and

hospital sector. The organisation represents 40 hospitals at four levels, i.e. university hospitals, regional hospitals, local hospitals and day care hospitals. At internation level, LHA strongly cooperates with HOSPEEM, HOPE, the International Hospitals Federation and with hospital organisations of the other Baltic states. At national level, LHA participates in the tripartite social dialogue and in the sectoral social dialogue, whilst locally it carries out collective bargaining at hospital level. LHA is at the forefront in advocating for more resources for the healthcare system in Latvia, where the government spending on healthcare as a share of GDP is still just around 3%.

The Dutch solution to the legal transposition of medical sharps

Dutch legislators give employers and employees at sector level a significant degree of responsability for health and safety policy. The development of Health and Safety Catalogues is an outcome of this policy in the Netherlands. The Health and Safety catalogue for the hospital sector has been developed for all members of NVZ-Nederlandse Vereniging van Ziekenhuizen and organisations covered by the collective agreement of the hospital sector. It also covers the use of medical sharps. Read more.



EU NEWS

A new Strategic Framework on Health and Safety at Work 2014 - 2020

On 6 June 2014, the European Commission published the new EU Strategic Framework on occupational safety and health (OSH). The communication recognises that there is already a comprehensive body of existing EU OSH legislation and therefore focuses on better enforcement and simplification of existing legislation. Three key objectives are outlined: Improving implementation of legislation in Member States; improving the prevention of work-related diseases; and tackling demographic change. It also states that specific attention should be given to addressing the impact of changes in work organisation in terms of physical and mental health. However, it is important to note that actions to achieve the strategic objectives are mostly tools of non legislative nature as the exchange of experience and practice. No new legislative proposals are included. HOSPEEM welcomes the recognition by the EC of the important role that EU Social Dialogue plays in the OSH field and the support that it has committed to provide to EU social partners for the implementation of this new strategy. EC Communication on effective, accessible and resilient health systems

On 4 April 2014, the European Commission published the Communication on effective, accessible and resilient health systems that recommends to Member States measures to strengthen effectiveness, increase accessibility and improve resilience of health systems to make them capable of adapting to changing environments and identifying innovative solutions. Amongst others, the Communication is based on the 2014 Annual Growth Survey emphasizes the need to improve the efficiency, financial sustainability and effectiveness of healthcare systems, to reach the objective of building competitiveness and growth. On 2 June 2014, the European Commission published specific recommendations on budgetary, employment and other structural reforms that each Member State should carry out over the next 12-18 months to help them boost growth. Read the recommendations for your country.

Flash Eurobarometer reports on working conditions

In April 2014, the European Commission published the Flash Eurobarometer 398. This survey was designed to explore a range of questions about working conditions and occupational health and safety. Results are first analysed at EU level, and then comparisons between individual Member States are made. Read more.

A directive to improve enforcement of workers' free movement rights

The European Commission welcomes today's adoption by the EU's Council of Ministers of a new Directive to ensure the better application at national level of EU citizens' right to work in another Member State. The new rules aim to bridge the gap between rights and reality and will make it easier for people working or looking for a job in another country to exercise their rights in practice. Member States now have two years to implement the Directive at national level. Read more.

On 5 May 2014, the European Commission launched a public consultation on the "Europe 2020 strategy: towards a post-crisis growth strategy for Europe". Read the press release.
