The Steering Committee in its new composition confirmed Ms **Neuhauser** and Ms **Gentile** as **Vice-Secretary Generals** of HOSPEEM with a three-year mandate.

HOSPEEM-EPSU Sectoral Social Dialogue Meeting: discussion about Work-Programme 2013-2015

At the meeting held on 25 June 2013, HOSPEEM presented its proposals for the new work programme of the Sectoral Social Dialogue Committee for the Hospital Sector for the period 2013/2014-2015. The topics proposed to EPSU, as agreed at the HOSPEEM General Assembly held the day before and on the basis of previous written consultations with members, focus on three main areas: follow-up to the Sharps project, well-being at the workplace and ageing workforce, and recruitment and retention. EPSU members will discuss their priorities and the HOSPEEM proposals at the EPSU's Standing Committee "Health and Social Services" on 15 October 2013.

At the next HOSPEEM-EPSU Social Dialogue meeting of 23 October 2013, the discussion about the Work-Programme 2013/2014-2015 will be one of the main points on the agenda. On the basis of the outcome of this discussion, a comprehensive proposal will be prepared to be discussed and agreed at the Social Dialogue Plenary meeting on 11 December 2013.

Health and safety at work: HOSPEEM to respond to the public consultation on future EU policy framework

The European Commission has launched a public consultation to gather insights and contributions from the public further to results of the evaluation of the European Strategy on Safety and Health at Work 2007-2012. The consultation will be open until 26 August 2013.

The aim of the consultation is to identify current and future challenges in the occupational safety and health area and instruments to tackle these challenges.

At the meeting of the Sectoral Social Dialogue Committee for the Hospital Sector on 25 June 2013, HOSPEEM and EPSU discussed the possibility to issue a joint reply to the consultation. HOSPEEM and EPSU Secretariats will work to produce a draft document that will then be sent to members for approval.

Follow-up and implementation of the multi-sectoral guidelines to tackle work-related third-party violence

HOSPEEM together with EPSU, UNIeuropa, ETUCE, CEMR, EFEE, EuroCommerce and CoESS issued in May a survey on the use and implementation of the Multi-sectoral guidelines to tackle third-party violence and harassment related to work. The deadline for replies expired on 15 July. We kindly ask to HOSPEEM members who have not sent their reply yet, to do so as soon as possible.

CEEP at informal Troika in Vilnius: focus on reduction of youth unemployment, Vilnius, 11 July 2013

Public services are key in providing jobs for the future, this was the key message delivered by Kate Ling, NHS and Vice Chair of CEEP's Education and Training Task Force, at the meeting of the European Social Partners with the European Ministers of Employment and Social Security held in Vilnius on 11 July. A major part of the meeting was devoted to how to implement the recently launched European Alliance for Apprenticeships.

Social partners' involvement in European economic governance

On 10 June 2013 the European social partner ad-hoc group on economic governance agreed upon a draft text for a joint declaration on social partner involvement in European economic governance. HOSPEEM, as a member of CEEP, unanimously approved the joint declaration at its General Assembly meeting on 24 June.

Professional Qualifications Directive: agreement found, 12 June 2013

On 12 June 2013 the European Parliament, the European Commission and the Council reached the trialogue agreement on the modernisation of the Directive 2005/36/EC on the recognition of professional qualifications. After going through the co-decision processes in the European Council and Parliament, the contents of the revised Directive were agreed subject to the vote of the European Parliament in autumn 2013.

The new directive on the exposure of workers to electromagnetic fields was published in the Official Journal of the EU on 29 June 2013. The Member States have until 1 July 2016 to transpose the new provisions.

HOSPEEM, who has lobbied for this revision through its member NHS, welcomes this news. In its old form, the Directive would have prevented patients from benefiting from MRI used in the diagnosis and treatment of their life-threatening diseases.
